#### September 3, Charleston Riverdogs promote Septembers' National Preparedness Month

Low country CERT and The State Citizens Corps Coordinator, Chris Perez joined with the Charleston Riverdogs Baseball Team to promote citizen preparedness for National Preparedness Month.

LCERT Members had a table set up on the concourse to hand out promo items, including raffle tickets for some preparedness starter kits. LCERT Members also distributed Ready Lowcountry preparedness materials. The Riverdogs also showed preparedness messages on the jumbo-tron.

#### September 28, SKYWARN Basic Weather Spotter Class

Charleston County EMD Hosted a SKYWARN Basic Weather Spotter Class.

SKYWARN<sup>TM</sup> is a voluntary program developed by the National Weather Service (NWS) to improve the warning program. SKYWARN<sup>TM</sup> volunteers serve as storm spotters for the NWS and local emergency management programs. Thirty one participants attended the class.

Charleston County Emergency Management Department is offering free classes for citizens who want to help warn officials about local weather changes.

The Basic Weather Spotter Class is required to become a certified NWS SKYWARN<sup>TM</sup> weather spotter and to take the Advanced Weather Spotter Class. The advanced class provides additional information and training to those interested in learning more than is provided in the basic class.
